DETAILS OF POST AND TERMS AND CONDITIONS

GENERAL MANAGER (PROJECTS) - 01 VACANCY

Essential Educational Qualification: Full time regular B.E/ B.Tech in Naval Architecture/ Mechanical/ Electrical/ Production/ Electronics/ Shipbuilding from a recognised university/ AICTE approved institution.

Essential Work Experience: The applicant should have post qualification work experience of minimum 20 years. Further, the applicant should have atleast 3 years' experience in a senior position as Head of the Project during the last ten years in construction / repair of a major naval project (Aircraft Carrier/ Destroyer/ Frigate/ Corvette).

Desirable: Should have managerial work experience in shipbuilding/ repair including design, production and planning. Should be well versed with production techniques and have command over naval standards related to shipbuilding. Should have command of operation research techniques like PERT, CPM, Scheduling and have knowledge of entire Production Planning and Control domain. Should have a working knowledge of ERP/ project management software. Apart from subject expertise, should possess effective people skills, apt policy conceiving/ designing and implementation skills, entrepreneurial skills, demonstrative leadership abilities, team building and strategic planning. Should have sound resource management skills towards enhancing quality and standards of the delivery mechanisms and output to internal and external customers.

Officers from Indian Navy presently serving in the Pay Level 13 for a minimum of 2 years as on cut-off date or equivalent in Army / Air Force /Coast Guard may also apply, if meeting the above eligibility criteria.

GENERAL CONDITIONS:

- 1) The candidates may note that the applications are to be made only through online application system as per the instructions given. Applications made in any other manner shall not be considered and shall be summarily rejected. Management will not be responsible for any application which is not received through online system. After completion of online registration and entering all the details, the candidates are required to take print out of online application form for their records. Candidates should produce the same along with relevant documents at the time of interview / document verification or whenever called for by GSL.
- 2) Application fee in the form of Demand Draft of ₹ **500/-** (Non-Refundable) in favor of "**Goa Shipyard Limited**" payable at Vasco-da-Gama, Goa is to be submitted per application. Application without prescribed fees shall be liable for rejection. No fee is to be paid by SC/ST/Ex-Servicemen candidates as per Government of India rules. No fee is required to be paid by internal candidates who apply for the said post.

- 3) Candidates are required to post only the original Demand Draft to Goa Shipyard Limited. The candidates have to **mandatorily** write their Application / Job Registration number, Name, Mobile Number, Name of the post and Advertisement No. on the reverse side of Demand Draft.
- 4) Non-receipt of Demand Draft (from UR and OBC/EWS candidates), Demand Drafts not as per the prescribed norms or those Demand Drafts received after the last date shall not be considered and shall be treated as **"REJECTED"** and no communication will be made for the same.
- 5) Management reserves the right to fill or not to fill the post and also to fill up future vacancies, if any from the valid panel of selected candidates as per the rules of the company.
- 6) Mere fulfillment of qualifications and other requirements as laid down does not entitle a candidate to be called for selection process as applicable for the respective post in accordance to the GSL rules.
- 7) SC/ST/OBC/EWS candidates applying for the above will be treated as General candidates as no relaxation in any criteria will be applicable to these candidates. However they will have to submit caste certificate, in the Prescribed Performa meant for **"Appointment to posts under the Government of India"** from the designated authority indicating clearly the candidate's caste, the Act/Order under which the caste is recognized as SC/ST/OBC (NCL) and the Village/Town the candidate is ordinarily a resident of. The OBC (NCL) certificate should not be more than 06 months old at the time of joining. Similarly, the candidates under Economically Weaker Section (EWS) category will have to submit the EWS certificate and other relevant documents issued by the competent authority.
- 8) If the SC/ST/OBC/EWS certificate has been issued in a language other than English/Hindi, the candidates will be required to submit a self-certified translated copy of the same either in English or Hindi. GSL reserves the right to verify the genuineness of the certificate and in case of false findings, necessary action will be taken against such candidates as per rules of GSL and Government guidelines as applicable.
- 9) Benefits for posts such as DA, HRA and other allowances will be applicable to the grade as per rules.
- 10) Candidates working in Government / Quasi Government / Public Sector Undertaking / Autonomous Bodies must apply through proper channel or produce **"No Objection Certificate"** at the time of selection process without which the candidates will not be allowed for the selection process and also a document indicating the current pay scale and the date since working in the said pay scale is to be produced.

- 11) **Out of the total overall experience mentioned, the candidates employed in Government / PSU applying for the post must possess last experience in the immediate lower payscale as below:-**

In case of candidates working in private sectors, last 2 years out of total years of experience should be in an organization/Company having annual turnover of Rs. 500 Crores or more and the incumbent should have discharged duties in a similar role.

- 12) Management reserves the right to appoint / rotate any employee in any position as per requirement of Company, irrespective of position he has been originally selected for.
- 13) Outstation candidates called for interview will be paid to and fro economy class Air fare by the shortest route from the place of residence to Vasco-Da-Gama, Goa and back on production of proof of journey (Hard copy of Tickets) as per rules of the Company.
- 14) Payment of TA shall be made through ECS mode after completion of the selection process only and candidates are expected to bring necessary details for making the payment through ECS mode. Normally TA claims will be paid within one month from the date of selection process. Application format along with ECS form is available on our website under the heading "Advertisements".
- 15) For any dispute, the Jurisdiction shall be Goa only.
- 16) Interim enquiries will not be entertained.
- 17) Canvassing in any form may lead to disqualification of candidature.
- 18) Ex-Servicemen can also apply against the advertised post. Their candidature will be considered as per Government guidelines in vogue.
- 19) Relaxation in age limit for Ex-Servicemen will be as per Government of India guidelines in force.
- 20) Internal candidates may get additional relaxation for age as per GSL Rules.

- Passport size color Photograph with light background (preferably white) without any obstacle covering/obstructing the face and eyes. Size of the file should be below 450 kb.
- Candidate's signature should be on a plain white paper with black ink. The signature should not be digitalized. It should be scanned copy of your own signature on paper with pen. Size of the file should be below 450 kb.
- Demand Draft Size of the file should be below 500kb.
- Scanned copy of SSC certificate as proof of date of Birth not more than 500 kb in size.
- Scanned copy of Educational qualification marksheet & degree not more than 01Mb.
- Scanned copy of Caste / Disability certificate not more than 500 kb.
- Scanned copy of experience certificates not more than 1 MB.
