DETAILS OF POST AND TERMS AND CONDITIONS

1.Deputy General Manager - (Weapon) - 01 Vacancy

<u>Essential Educational Qualification</u>: Full time Bachelor of Engineering (B.E.)/ Bachelor of Technology (B.Tech.) from a recognized University/ AICTE approved institution with specialization in Electrical Engineering/ Electronics & Communication Engineering. Officers serving in Indian Navy may also apply. Naval Commander/ Captains(of Electrical branch of Indian Navy) can apply. **Indian Navy Commanders with more than 13 years of service shall be eligible for DGM grade**.

Essential Work Experience: The candidate should have 13 years post qualification relevant experience (not below the rank of Commander of Indian Navy with 13 years of service). The naval candidate should have experience in WOT/ Design Directorate/ Professional Directorate/ Trial agencies/ WESSIE/ Naval Dockyards.

<u>Desirable Experience</u>: Relevant experience in ship design/ shipbuilding/ IHQ (Professional Directorate)/ WOT etc. or in assignments involving new ships designs/ construction/ overseeing/ commissioning crew on a Frigate/ Destroyers etc. and projects management software like Primavera, ERP and work experience in system integration/ production/ planning/ design/ quality control etc. in ships construction industry.

2. Deputy General Manager - (Hull) - 01 Vacancy

Essential Educational Qualification: Full time Bachelor of Engineering (B.E.)/ Bachelor of Technology (B.Tech.) from a recognized University/ AICTE approved institution with specialization in Naval Architecture. Officers serving in Indian Navy may also apply. Naval Commander/ Captains (of Naval Architect Branch) may also apply. Indian Navy Commanders with more than 13 years of service shall be eligible for DGM grade.

Essential Work Experience: The candidate should have 13 years post qualification relevant experience (not below the rank of Commander of Indian Navy with 13 years of service). The naval candidate should have experience in WOT/ Naval Design Directorate/ Professional Directorate/ Trail agencies.

<u>Desirable Experience:</u> Relevant experience in ship design/ shipbuilding/ IHQ (Professional Directorate)/ WOT etc. or in assignments involving new ship designs/ construction / overseeing/ Defence Acquistion procedures and experience in project management software like Primavera, ERP and also in production/ planning/ design/ quality control etc., in ships building industry.

3. Senior Manager (Project Coordination - Delhi Office) - 01 Vacancy

Essential Educational Qualification: Full time Bachelor of Engineering (B.E) / Bachelor of Technology (B.Tech) from a recognised University / AICTE approved Institution with specialization in Mechanical Engineering / Production Engineering/ Naval Architecture / Electrical Engineering / Electronics Engineering/ Instrumentation Engineering.

<u>Desirable Qualification</u>: Any higher Degree / Diploma / Certificate Course from a recognized University / AICTE approved institution in Mechanical / Electrical / Electronics / Naval Architecture / Project Management or MBA.

Essential Work Experience The candidate should have minimum 10 years Post Qualification experience in ship building/Ship repair industry. Naval Candidate should have work experience in WOT / Design Directorate / Professional Directorate / Trial Agencies / Naval Dockyards. Indian Navy Lieutenant Commanders with above qualification and more than 10 years service as an officer in Indian Navy shall also be eligible.

Desirable Experience:

Relevant Managerial work experience in the areas of Fabrication / Outfitting / Design / Production / Planning / Cost Estimation / Project Costing / Project Management, Repair and Maintenance, Commercial Functions / Contract Negotiations / Materials Procurement, Product Development, Analysis and Evaluation etc. in Ships and associated peripherals / Engineering systems

GENERAL CONDITIONS:

- 1) The candidates may note that the applications are to be made only through online application system as per the instructions given. Applications made in any other manner shall not be considered and shall be summarily rejected. Management will not be responsible for any application which is not received through online system. After completion of online registration and entering all the details, the candidates are required to take print out of online application form and post the same along with the Demand Draft to Goa Shipyard Limited.
- 2) An application fee in the form of Demand Draft of ₹ 500/- (Non-Refundable) in favor of "Goa Shipyard Limited" payable at Vasco-da-Gama, Goa is to be submitted per application. Application without prescribed fees shall be liable for rejection. SC/ST/PwBD/Ex-Servicemen candidates are exempted from payment of application fee,as per Government of India rules. No fee is required to be paid by internal candidates who apply for the said post.
- Candidates are required to forward a print out of the online application and the original Demand Draft by post to Goa Shipyard Limited. The candidates shall **mandatorily** write their Application / Job Registration number, Name, Mobile Number, Name of the post and Advertisement No. on the reverse side of Demand Draft.
- 4) Non-receipt of hardcopy of the online application and Demand Draft, Demand Drafts not as per the prescribed norms or the hard copy of online applications and Demand Drafts received after the last date, shall not be considered and shall be treated as "**REJECTED**" and no communication will be made in this regard.

- 5) Management reserves the right to fill or not to fill the post and also to fill up future vacancies, if any, from the valid panel of selected candidates as per the rules of the company. GSL Management in its sole discretion reserves the right to increase / reduce the number of vacancies notified.
- 6) Mere fulfillment of qualifications and other requirements as laid down does not entitle a candidate to be called for selection process as applicable for the respective post in accordance to the GSL rules.
- 7) The requisite work experience should have been completed within a period not earlier than three years from the cutoff date 31.10.2021 as per the advertisement.
- SC/ST/OBC(NCL)/EWS candidates applying for a post where there are no vacancies in their respective reserved categories will be treated as General candidates and no relaxation in any criteria will be applicable to these candidates. However they will have to submit caste certificate, in the Prescribed Proforma meant for "Appointment to posts under the Government of India" from the designated authority indicating clearly the candidate's caste, the Act/Order under which the caste is recognized as SC/ST/OBC (NCL) and the Village/Town the candidate is ordinarily a resident of. The OBC (NCL) certificate should not be more than 06 months old at the time of joining. Similarly, the candidates under Economically Weaker Section (EWS) category will have to submit the EWS certificate and other relevant documents issued by the competent authority. The candidates under PwBD category will have to submit the disability certificate from the designated authority, indicating clearly the percentage of disability.
- 9) If the SC/ST/OBC/EWS/PwBD certificate has been issued in a language other than English/Hindi, the candidates will be required to submit a self-certified translated copy of the same either in English or Hindi. GSL reserves the right to verify the genuineness of the certificate and in case it is found to be false penal action will be taken against such candidates as per rules of GSL and Government guidelines as applicable.
- 10) For the posts mentioned above, in addition to the basic pay, benefits such as DA, HRA and other allowances will be applicable to the grade as per rules.
- 11) Candidates working in Government / Quasi Government / Public Sector Undertaking / Autonomous Bodies must apply through proper channel or produce "No Objection Certificate" at the time of selection process without which the candidates will not be allowed for the selection process and also a document indicating the current pay scale and the date since working in the said pay scale is to be produced.
