DETAILS OF POST AND TERMS AND CONDITIONS

1. GENERAL MANAGER (PROJECTS) - 01 VACANCY

Essential Educational Qualification: Full time regular B.E/ B.Tech in Naval Architecture/ Mechanical/ Electrical/ Production/ Electronics/ Shipbuilding from a recognized university/ AICTE approved institution.

Essential Work Experience:

The applicant should have post qualification work experience of minimum 20 years in Shipbuilding activities such as Designing, Production Planning and Project Management etc. Candidates having work experience in Naval Establishments such as Naval Dockyards, Repair Yards, Production Directorates, Design Directorates, WOTs, etc will be preferred.

Desirable: Should have managerial work experience in shipbuilding/ repair including design, production and planning. Should be well versed with production techniques and have command over naval standards related to shipbuilding. Should have command of operation research techniques like PERT, CPM, Scheduling and have knowledge of entire Production Planning and Control domain. Should have a working knowledge of ERP/ project management software. Apart from subject expertise, should possess effective people skills, apt policy conceiving/ designing and implementation skills, entrepreneurial skills, demonstrative leadership abilities, team building and strategic planning. Should have sound resource management skills towards enhancing quality and standards of the delivery mechanisms and output to internal and external customers.

Officers from Indian Navy presently serving in the Pay Level 13 for a minimum of 2 years as on cut-off date or equivalent rank in Army / Air Force /Coast Guard may also apply, if meeting the above eligibility criteria.

GENERAL CONDITIONS:

- 1) The candidates may note that the applications are to be made only through online application system as per the instructions given. Applications made in any other manner shall not be considered and shall be summarily rejected. Management will not be responsible for any application which is not received through online system. After completion of online registration and entering all the details, the candidates are required to take printout of online application form and post the same along with the original Demand Draft to Goa Shipyard Limited.
- 2) Application fee in the form of Demand Draft of ₹ **500/-** (Non-Refundable) in favor of “**Goa Shipyard Limited**” payable at Vasco-da-Gama, Goa is to be submitted per application. Application without prescribed fees shall be liable for rejection. SC/ST/Ex-Servicemen candidates are exempted from payment of application fee, as per Government of India rules. No fee is required to be paid by internal candidates who apply for the said post.
- 3) Candidates are required to forward a printout of the online application and the original Demand Draft by post to Goa Shipyard Limited. The candidates shall **mandatorily** write their Application / Job Registration number, Name, Mobile Number, Name of the post and Advertisement No. on the reverse side of Demand Draft.
- 4) Non-receipt of hardcopy of the online application and Demand Draft, Demand Drafts not as per the prescribed norms or the hard copy of online applications

and Demand Drafts received after the last date shall not be considered and shall be treated as **“REJECTED”** and no communication will be made in this regard.

- 5) Management reserves the right to fill or not to fill the post and also to fill up future vacancies, if any from the valid panel of selected candidates as per the rules of the company. GSL Management in its sole discretion reserves the right to increase / reduce the number of vacancies notified.
- 6) Mere fulfillment of qualifications and other requirements as laid down does not entitle a candidate to be called for selection process as applicable for the respective post in accordance to the GSL rules.
- 7) SC/ST/OBC/EWS candidates applying for the above will be treated as General candidates as no relaxation in any criteria will be applicable to these candidates. However they will have to submit caste certificate, in the Prescribed Proforma meant for **“Appointment to posts under the Government of India”** from the designated authority indicating clearly the candidate’s caste, the Act/Order under which the caste is recognized as SC/ST/OBC (NCL) and the Village/Town the candidate is ordinarily a resident of. The OBC (NCL) certificate should not be more than 06 months old at the time of joining. The candidates under Economically Weaker Section (EWS) category will have to submit the EWS certificate and other relevant documents issued by the competent authority.
- 8) If the SC/ST/OBC/EWS certificate has been issued in a language other than English/Hindi, the candidates will be required to submit a self-certified translated copy of the same either in English or Hindi. GSL reserves the right to verify the genuineness of the certificate and in case it is found to be false penal action will be taken against such candidates as per rules of GSL and Government guidelines as applicable.
- 9) For the posts mentioned above, in addition to the basic pay benefits such as DA, HRA and other allowances will be applicable to the grade as per rules.
- 10) Candidates working in Government / Quasi Government / Public Sector Undertaking / Autonomous Bodies must apply through proper channel or produce **“No Objection Certificate”** at the time of selection process without which the candidates will not be allowed for the selection process and also a document indicating the current pay scale and the date since working in the said pay scale is to be produced.
- 11) **Out of the total overall experience mentioned, the candidates employed in Government / PSU applying for the post must possess last experience in the immediate lower payscale as below:-**

In case of candidates working in private sectors, last 2 years out of total years of experience should be in an organization/Company having annual turnover of Rs 500 Crores or more and the incumbent should have discharged duties in a similar role.

- 12) Management reserves the right to post/engage the selected candidates in any position as per requirement of Company, irrespective of the post he/she has been originally selected for.
- 13) Outstation candidates called for interview will be paid to and fro economy class Air fare by the shortest route from the place of residence to Vasco-Da-Gama, Goa and back on production of proof of journey (Hard copy of Tickets) as per rules of the Company.
- 14) Payment of TA shall be made through ECS mode only after completion of the selection process and candidates are expected to bring necessary details for making the payment through ECS mode. Normally TA claims will be paid within one month from the date of selection process. Application format along with ECS form is available on our website under the heading "Advertisements".
- 15) For any dispute, the Jurisdiction shall be Goa only.
- 16) Interim enquiries will not be entertained.
- 17) Canvassing in any form will be a disqualification of their candidature.
- 18) Ex-Servicemen can also apply against the advertised post. Their candidature will be considered as per Government guidelines in vogue.
- 19) Relaxation in age limit for Ex-Servicemen will be as per Government of India guidelines in force. However the upper age limit of the applicant, considering all the age relaxations should not exceed 56 years as on cut off date.
- 20) Internal candidates may get additional relaxation for age as per GSL Rules.
- 21) Management reserves the right to raise the eligibility criteria for short listing the applications. Management further reserves the right to decide the criteria for screening of applications and internal rules and regulations and / or the procedures as per the past practice will be followed. In respect of highly deserving cases age relaxation may be granted suitably to the candidates who possess the relevant qualification and experience as notified. - Passport size color Photograph with light background (preferably white) without any obstacle covering/obstructing the face and eyes. Size of the file should be below 450 kb.
- Candidate's signature should be on a plain white paper with black ink. The signature should not be digitalized. It should be scanned copy of your own signature on paper with pen. Size of the file should be below 450 kb.
- Demand Draft Size of the file should be below 500kb.
- Scanned copy of SSC certificate as proof of date of Birth not more than 500 kb in size.
- Scanned copy of Educational qualification marksheet & degree not more than 01Mb.
- Scanned copy of Caste certificate not more than 500 kb.
- Scanned copy of experience certificates not more than 1 MB.
