Tentative Syllabus for the post of Office Assistant (Finance / Internal Audit) is as under:

The duration of the written test will be of one hour. The written test paper shall be of Multiple Choice Questions types and consists of questions on general knowledge (25 % approx) and remaining on commerce subjects of B Com level. The questions will be set on Accounting, Audit, Taxation (Both Direct Taxes and Indirect Taxes including GST), Financial Management, Business laws etc. Based on the performance of candidates in written test, Practical Test will be conducted on general office administration and computer skill.

General Instructions to the candidates appearing for the Written test:
