Please note that you are being called on an understanding that you possess minimum qualification of ITI & NCTVT (National Apprenticeship Certificate) in Fitter / Fitter General or ITI in Fitter / Fitter General and required work experience as specified in the advertisement i.e. the candidate should possess minimum 2 years experience in the line. Verification of certificates and relevant documents will be conducted if you qualify in the written test.
